Sub:- Renewal of annual recognition to National Sports Federations (NSFs) for the year 2015.


Sir.

It has been decided with the approval of the competent authority to renew the annual recognition for the year 2015 i.e. upto 31<sup>st</sup> December, 2015 to the 48 NSFs indicated in the list at **Annexure-I**. Recognition to the 4 NSFs, as per list at **Annexure-II**, have been accorded only upto 31-03-2015 for the reasons indicated against each. Continuation of recognition beyond 31-03-2015 for the 3 NSFs viz Wushu Association of India, Wrestling Federation of India and Gymnastics Federation of India will be considered in due course based on the documents submitted by them. Continuation of recognition beyond 31-03-2015 to All India Tennis Association will be considered after the issue of holding election to the post of President is resolved.

- Each of the NSFs listed in Annex-I & Annex-II are required to upload documents as per the list enclosed as Annexure-III on their website within one month of issue of this letter and report compliance in this regard along with their website address latest by 15-03-2015. Non-compliance in this regard may result in cancellation of this renewal without notice and without any liability on MYAS.
- Accordingly, the NSFs indicated at Annex-I & II are eligible to receive various assistance from the Government of India including railway concessions etc., as may be admissible to them during the aforesaid period of their recognition.
- This issues with the approval of the Hon'ble MOS (I/C) YAS.



The following Federations have been given recognition upto 31-03-2015 for the reasons specified against each of them:-

Sl.No.	Name of the NSFs	Reasons
1.	All India Tennis Association (AITA)	All India Tennis Association was asked to hold fresh elections for the post of its President vide this office order no.37-11/2009-SP-I dated 22-10-2014. AITA has not so far complied with the said instructions. They have submitted a representation for review of the decision. The same is under examination.
2.	Gymnastics Federation of India (GFI)	GFI has held the election on 28-01-2015. The report of the election is awaited. Recognition to GFI, beyond 31-03-2015, will be considered based on the report of the election and other relevant factors.
3.	Wrestling Federation of India (WFI)	WFI has submitted a copy of their amended constitution, duly acknowledged by the ROC, on 16-01-2015. The same is under examination.
4.	Wushu Association of India (WAI)	The validity of Registration Certificate has expired on 28.08.2014. They have submitted a copy of the renewal certificate on 29-01-2015. The same is under examination.

6. Notifying/updating the Selection Committee for national athletes for the next calendar year.
7. Note on efforts for having dope free sports and compliance to WADA/NADA Code along with details of cases found positive during the last calendar year and action taken thereon.
8. Details of holding of national championships conducted during the current calendar year
9. Calendar for national championships to be held in the next calendar year.
10. Note regarding updating the Web-site
